## WORK HISTORY

On graduation in 1971 I opened a consultancy (sole proprietor) - *FUTURES - Socio-Economic Planning Consultants* - conducting policy research in the fields of cultural economics, futures studies, intellectual property, public assistance, public finance and urban affairs. Clients included:

Canada Council, Canadian Bureau of Intellectual Property, Canadian Federation of Mayors & Municipalities, Ottawa-Carleton Regional Review, Public Service Commission of Canada, Secretary of State Canada, Social Sciences & Humanities Research Council, Tri-level Task Force on Public Finance

From December 1981 to September 1989, I served as Research Director for the Canada Council for the arts managing a staff of nine and an annual research budget of \$500,000. During my tenure, I:

- i - designed and implemented an integrated research and evaluation monitoring system tracking the Council's administration, granting and client activities and creating the largest cultural economics research library in the English-speaking world;
- ii - acted as consultant to international, national, regional and local authorities, professional associations and sister agencies at home and abroad including UNESCO; and,
- iii - prepared the Council's Multi-Year Operational Plan and annual \$100 million application for funding from the Government of Canada.

From September 1989 to June 1994, I served as Chief Economist (sole proprietor) of *Kultural Econometrics International* researching and evaluating Canadian, foreign and international cultural economic and higher education policies and practices. Clients included:

In 1998 I became a Lecturer with the Department of Economics at the University of Saskatchewan. Since then I have taught introductory and intermediate micro- and macro-economics; the economics of biotechnology; international economic development, history of economic thought, industrial organization, intellectual and cultural property rights including personal information; and served as academic adviser to the USASK Business Economics Internship Program for 3 years.

In 2002 I began the interdisciplinary PhD program at the University of Saskatchewan which I successfully completed in July 2006. My dissertation was: *Ideological Evolution: The Competitiveness of Nations in a Global Knowledge-Based Economy*.

In addition to the Department of Economics between 2004 and 2006 I taught introductory micro- and macro-economics at St. Thomas Moore College as well as [History of Economic Thought Econ 380](#) and [International Development, Econ 270](#). In 2006 I also taught [Contemporary Economic Issues BCS 331](#) for the [University of the Arctic](#). In 2008-9 I taught the [Economics of Biotechnology BPBE 292](#), College of Agriculture, USASK.

With the exception of a lecture series: [A Primer on Economics: "X" Marks the Spot](#) sponsored by the Johnson & Shoyama Graduate School of Public Policy (Sept. - Oct. 2009), and arguably due to the Great Recession, no work was available at USASK in 2009-10. Accordingly, in 2011-12, I taught at Okanagan College where in addition to introductory micro- and macro-economics I taught [Ecological, Environmental & Natural Resource Economics, Econ 271, Okanagan College](#).

In 2012-2014 I served at the University of New Brunswick Saint John as Assistant Professor. While at UNBSJ I taught introductory micro- and macro-economics; created and taught a [Survey of Intellectual & Cultural Property in the Global Village Econ 3593, UNBSJ](#);

and, taught [Introduction to Industrial Organization](#) MBA 7003, UNBSJ at the School of Business. I also presented two lecture series:
